



# Educational Content and Recording Agreement

This agreement (“Agreement”) is made and entered into, as of \_\_\_\_\_ [DATE] (“Effective Date”), between \_\_\_\_\_ [NAME] (“Contractor”) and the International Society of Exercise Oncology (“ISEO”).

Contractor agrees to create content for an educational resource which may include but is not limited to a blog, infographic, handout, video, podcast, live webinar, or an on-demand educational resource which will cover information/topics requested by ISEO and agreed to by the Contractor.

All content, documents, records, data, videos, articles, and other materials (the “Materials”) not developed or licensed by the Contractor prior to execution of this Agreement, but specifically developed under this Agreement shall be considered “work for hire” and the Contractor hereby transfers and assigns any ownership claims to ISEO so that all Materials will be the property of ISEO. If ownership interest in the Materials cannot be assigned to ISEO, the Contractor grants ISEO a nonexclusive, non-cancelable, perpetual, worldwide royalty-free license to use the Materials and to use, modify, display, distribute, copy and create derivative works of the Materials. Contractor represents and warrants that the Material does not, in whole or in part, infringe any rights of any third party.

To the best of the Contractor’s knowledge, the Materials do not violate any proprietary or personal rights of others (including any copyright, trademark, and privacy rights), is factually accurate, and contains nothing defamatory or otherwise unlawful. Contractor has the full authority to enter into this agreement and has obtained all necessary permissions or licenses from any individuals or organizations whose material is included or used in the Materials. Contractor will not engage in any type of promotional marketing or selling of a product or service in the Materials or during a presentation (recorded or live).

Contractor agrees to comply with all related deadlines provided by ISEO, including but not limited to deadlines for content, objectives, submission of biographical information, and other materials as requested. Contractor authorizes ISEO to use Contractor’s name, likeness, photograph, and biographical data in connection with the use and promotion of the

Materials. During the development and for the life cycle of the content, Contractor will not disparage ISEO in any way. Contractor agrees to use ISEO-provided templates and materials for the purpose of this Agreement only. Contractor consents to recording the content and will be provided with a complimentary copy. Contractor agrees not to sell, distribute, stream, or otherwise use the recording in any way other than for personal, archival use, except with the prior written consent of ISEO.

Contractor understands this activity fulfills a service opportunity for ISEO and will not receive any royalties, honoraria, reimbursement of expenses, or other compensation from ISEO in connection with the program or the rights granted above unless otherwise indicated or agreed upon with ISEO.

Based on mutual consideration, Contractor hereby understands and agrees to the above terms and conditions.
