



## **Abstract Submission**

Abstracts can be submitted **until 1 May 2022** and have to be submitted via this website. Faxed or emailed abstracts cannot be considered.

Some of the submitted abstracts will be selected for a short talk by the Scientific Program Committee. Please indicate in the registration form whether you are prepared to give a short talk – if selected – or whether you prefer to present a poster.

*Submitters will immediately receive a confirmation of receipt and will be notified by end of July 2022 whether the abstract has been accepted for a poster presentation or a short talk.*

**Poster presenters** shall attend in person for the poster session (virtual posters currently not intended) and will have to register for on-site attendance via the registration form (scheduled to open early summer 2022). Participation fee as well as travel expenses and accommodation will not be covered by DKFZ.

**Speakers**, selected for a short talk will have a presentation time of 5 minutes inclusive a short Q&A round. At the end of each session there will be sufficient time for discussion. Selected speakers will be asked individually to register via the “invited speakers” registration form. For speakers, participation is free of charge and travel costs (economy only) will be covered and accommodation will be arranged by DKFZ in case they attend in person. We can also offer a remote connection for your session and virtual attendance for the remaining conference.

## **Abstract guidelines**

- The **number of submitted abstracts** is limited to one per presenting author.
- **Abstracts are reviewed** and selected for presentation by the scientific program committee. You will be notified in July 2022 whether you were selected for a **short talk or poster presentation**.
- **Abstract title** is limited to **125** characters (including blanks)
- **Abstracts** should not exceed **1600** characters (including blanks)
- Number of **tracks**, in which your abstract can be categorized, is limited to **only one**

- **Authors & Affiliations**

- o The presenting author has to be listed in the field "**author**" and has to be marked as „**speaker**“.
- o Please use the format given in the pop-up window: Spell out the **family name** "Public" - Abbreviate the **first name** "J." - and fill in the respective **affiliation, city, country**, e.g. "German Cancer Consortium, Heidelberg, Germany" - further details are not necessary!

## GENERAL RULES FOR SUBMISSION OF ABSTRACTS

1. The presenting author is required to ensure that all co-authors are aware of the content of the abstract before submission.
2. Submitted abstracts should include **non-published data**.
3. Abstracts **previously presented** will not be accepted.
4. All abstracts should be submitted and presented in **clear English** with **accurate grammar and spelling** of a quality suitable for publication. If you need help, please arrange for the review of your abstract by a colleague who is a native English speaker, by a university specific publications office (or other similar facility) or by a copy editor, prior to submission.
5. The submission form allows you to change your abstract until the abstract submission deadline. Please note that abstracts must be SUBMITTED before the deadline in order to be send.

## **ABSTRACT SUBMITTERS' DECLARATION**

*During abstract submission you will be asked to declare the following:*

1. I confirm that I previewed this abstract and that all information is correct. I accept that the content of this abstract cannot be modified or corrected after final submission and I am aware that it will be published as submitted.
2. Submission of the abstract constitutes the consent of all authors to publication (e.g. conference website, programs, other promotions, etc.)
3. The Abstract Submitter warrants and represents that no part of the information and content provided by him/her (Hereafter: the "Content") to the Organizers of the CCP2022 (Hereafter: the "Organizers"), nor the publication of any such Content by the Organizers, on the internet or otherwise infringes any third party rights, including but not limited to privacy rights and/or intellectual property rights.
4. The Abstract Submitter grants the Organizers a copyright license to reproduce, publish, translate, distribute, and display the text of the content on a royalty-free, perpetual, irrevocable nonexclusive basis.
5. I herewith confirm that the presenter is listed as "author" and marked as „speaker“. I understand that the contact details saved in this system for the author/speaker will be used for notifications on the status of the abstract. The presenting author/speaker is responsible for informing the other authors about the status of the abstract.
6. I understand that the presenting author must be a registered participant.
7. The Organizers reserve the right to remove an abstract from publication and/or presentation which does not comply with the above.
8. I understand that I have to select a specific "Track" for my abstract allocation. Although the Program Committee will work hard to honor this selection, this cannot be guaranteed. The Scientific Program Committee reserves the right to change the track.
